Prior to the execution of the Search Warrant, it had been reviewed for probable cause by Dan Bowman of the Clark County District Attorney's Office and approved by the Honorable Judge Doug Smith.

On the above date and time with Search Warrant in hand, Detectives approached the residence at 159 Palisade Avenue and observed the front door of the residence to be open

and a LMA to be standing on the porch. We made contact with this individual and presented him with a copy of the Search Warrant and were allowed peaceful entry into the premises. The target of this investigation was a HMA, identified as Franklin Heath having an ID#1194484, who was located in the master bedroom of the premises. Also in the master bedroom of the premises was a second male subject identified verbally as Jeffery Iverson, having a DOB: 04/17/74 and an LVMPD ID#1393211.

Prior to the search of the master bedroom, I, Detective Kelley, asked Franklin Heath if everything in the bedroom was his property. Heath indicated to me that everything was with exception of a gray in color backpack that was lying in plain view on the floor. Heath indicated this backpack belonged to and was brought to the residence by Jeff Iverson. I then asked Iverson if the backpack was in fact his property and he indicated it was. I asked Iverson for permission to search his backpack. He gave me verbal consent to do so and while conducting a search of the backpack I found a Red Swisher Sweets cigar box. Within this cigar box I found numerous items of narcotics paraphernalia to include hypodermic devices and a straw. Also inside the red cigar box was a small metal tin. As I opened this tin I observed a baggie containing a white powdery substance that through my training and experience I believed to be the controlled substance methamphetamine. I asked Iverson again if the substance believed to be methamphetamine was his property and he indicated it was. I asked him if it was in fact methamphetamine and he indicated. yes, at which time I placed him under arrest and advised him of rights per the Miranda I then asked Iverson to tell me about the recovered suspected methamphetamine at which time he indicated to me that the bag would contain approximately eight (8) grams of methamphetamine and that he had been responsible for the manufacturing of this product.

Iverson went on to tell me that he had a severe drug habit and that the eight grams contained in the bag would only last him a period of a few days. Upon arrival to the premises we noted a 1986 Honda to be parked in front of the premises. Iverson indicated to me that this was in fact his vehicle and produced a set of keys. I asked Iverson if there was anything within the vehicle I needed to know about and if so, could I have his consent to search the vehicle. Iverson initially indicated that there would be no more methamphetamine or firearms within the vehicle but said that there would be a methamphetamine lab located within a blue bag in the back of the vehicle covered by a blanket. I then asked for and received written consent to search the Honda from Iverson, at which time we conducted a search of the vehicle and did locate a blue in color duffel type bag that appeared to contain items associated with the manufacture of methamphetamine to include glassware and several items of a liquid substance.

At this point the search was suspended and LVMPD Narcotics Detail was notified to respond to process the suspected methamphetamine lab. Based upon the recovery of the suspected methamphetamine in the backpack belonging to Jeff Iverson I then transported him to the Clark County Detention Center where he was booked. Prior to his booking, I weighed and tested the substance recovered and found it to have a gross weight of 8.5 grams and to test positive for the controlled substance methamphetamine via the ODV Test System. The above substances were then impounded as evidence under LVMPD Event No. 020418-0876. In addition to the recovered suspected methamphetamine I, Detective Kelley, also found in the backpack a digital scale. This scale is a Palm Scale,

150 gram scale. This scale was subsequently impounded as evidence as Package 4, Item 6. It should be noted that additional charges will likely be forthcoming upon the conclusion of the Narcotics investigation by Narcotics Detectives.
