That I learned the following facts and circumstances which lead me to believe that the above named subject committed (or was committing) the offense of PCS-METH; PCS MARIJUANA at the location of 1052 SIERRA VISTA, LV NV 89105 (ADDRESS / CITY / STATE / ZIP) and that the offense occurred at approximately 0330 hours on the 14 day of AUGUST, 2004, in the county of Clark or ☐ City of Las Vegas, NV.

DETAILS FOR PROBABLE CAUSE:

ON 08-14-05 AT APPROXIMATELY 0335 OFFICER E. ORTEGA # 6747 AND I
OFFICER M. BREWER # 7426 OPERATING AS MARKED PATROL UNIT 10PN
CONDUCTED A PEDESTRIAN STOP ON A WOMAN ON A BICYCLE FOR
NOT HAVING THE PROPER SAFETY EQUIPMENT, LIGHTS.
I VERBALLY IDENTIFIED THE SUBJECT AS IVERSON, JEFFREY; 04-17-74; 530-08-6071.
I ASKED IVERSON IF HE HAD ANYTHING DANGEROUS OR ILLEGAL ON HIM. IVERSON
TOLD ME THAT IN HIS POCKET HE HAD MARIJUANA AND METH. I PULLED OUT OF HIS
POCKET A CLEAR BAG THAT CONTAINED MARIJUANA AND A SMALL PINK BAG
THAT CONTAINED METH.
IVERSON WAS ARRESTED FOR PCS METH AND PCS MARIJUANA. THE
METHAMPHETAMINE TESTED ODU POSITIVE, 16 GRM AND THE MARIJUANA WAS
ODU POSITIVE FOR 10. GRMS.
IVERSON WAS BOOKED ACCORDINGLY ON THE ABOVE CHARGES

CIRCUMSTANCES OF ARREST

OFFICER INVOLVED: Officer M. Brewer, P#7426, 1DPN

DETAILS:

On August 14, 2005, at approximately 0335 hours, I, Officer M. Brewer, P#7426, operating as marked patrol unit 1DPN, conducted a pedestrian stop on a white male adult on a bicycle for not having the proper safety equipment, lights. The subject was verbally identified as Jeffrey Iverson, date of birth 04/17/74, social security #530-08-6071. I asked Iverson if he had anything dangerous or illegal on him. Iverson told me, at that time, that in his pocket he had a bag of marijuana and a small bag of methamphetamine. Iverson told me that the marijuana and the methamphetamine was in the left hand pocket of his shorts. I told him that I was going to grab it and pull it out. He said it was okay to go into his pockets and grab whatever I wanted.

I reached into the left pocket of his shorts and pulled out a clear plastic bag which contained what later tested to be ODV positive marijuana, ten grams, and a small pink bag that contained ODV positive methamphetamine, .6 grams. Iverson was then placed under arrest for possession of a controlled substance methamphetamine and possession of a controlled substance marijuana. Based upon the fact that he advised me and admitted that the marijuana and methamphetamine was in his left pocket and was his. Iverson was transported to Clark County Detention Center and booked accordingly for the above stated charges.
